**MINIMUM QUALIFICATIONS**

1. **MUST** be at least eighteen (18) years of age.
2. **MUST** complete pages 1 and 2 of the Pipe Trades Apprenticeship Form #1 and return it to UA LOCAL UNION #41 - JATC with the following:

- a. Copy of Birth Certificate or other such document for proof of age;
  - b. Copy of High School diploma and transcript or High School equivalency (GED) certificate and official report of test results;
3. **All applicants** will be required to take complete an in person TAB (Test of Adult Basic Education) exam, in order to advance to the interview;
  4. **MUST** appear for an interviewed when notified;
  5. Before employment, all applicants accepted for probationary apprenticeship may be required to pass a physical examination as prescribed by the JATC. The expense of the examination will be paid for by the **applicant**.
  6. **MUST** possess, or be able to obtain, a valid Montana State Driver's License. **Provide a copy of your current Driver's License with the completed application.**


